Zurich: security and compliance

Our Zurich data centre provides an ultra-secure, known location for storing and processing data in line with Swiss data protection regulations. Like all of our data centres, in Zurich we operate in full accordance with the ITILv3 framework and has ISO 27001 and ISO 22301 certification. Our compliance with the FINMA circular 07/8 is externally audited.

Switzerland's liberal economic system, competitive tax regime, highly educated workforce and political stability make it the ideal location for organisations looking to establish operations in the heart of Europe. Although outside the EU, Switzerland has strong trading links with the EU and is bordered by three of its largest market economies.

This combination of factors makes our data centre in Zurich – the largest of its kind in Switzerland – the perfect European base for international organisations. It's also the data centre of choice for: Internet-based connectivity. Benefits of Cloud Connect include:

Flexibility and choice

We pioneered modular data centre design and have been refining it for 20 years to enable rapid and efficient expansion. We offer significant flexibility in what you do with your space and how you extend your footprint. The on-campus team can advise on best practice for cabling, cooling, and power delivery and management, and help you make the best choices on leased lines, IP transit, peering arrangements and physical cabling.

- Colocation in Cabinets, Cages and Private Room
- Rapidly installed Cross Connects
- 24x7 Hands and Eyes technical support service
- Meeting rooms and office space



Security, reliability, sustainability

When you colocate with us, you can be confident about the physical security of your systems, the performance of your infrastructure, and its availability – assured with a 99.999% availability SLA. And if sustainability is high on your agenda, that's covered too.

For 20 years we've been setting industry standards in data centre design, build, operation and management to deliver continually improving reliability, security, resilience, efficiency and performance.



Security

The data centre is monitored 24x7 by CCTV and security patrols. There are multiple access barriers, including mantraps, contactless key cards and biometric readers. You can also add your own security systems to a Private Room.



Operational excellence

Like all our data centres, Zurich has ISO 27001 and BS 25999 certification. We combine state-of-the-art systems and processes to monitor and manage operations 24x7, combining on-the-ground local teams with centralised oversight by our 24-hour multi lingual European Customer Service Centre (ECSC).





Resilience and business continuity

From 24x7 monitoring and alarms for every critical system to incident and business continuity management, we follow best practice and operate in accordance with the ITILv3 framework. High levels of redundancy and service assurance are built into our data centres:

- **Connectivity** - quadruple-entry fibre from separate carrier main routes and rapidly installed Cross Connects.
- **Power** - secured power grid supply from two substations from two different power providers; two power feeds for all equipment, each independently equipped with UPS and generator backup with full load capacity for indefinite running.
- **Environment** - SLAs on temperature and humidity in line with ASHRAE recommendations; N+1 cooling; sophisticated water and very early smoke detection systems; Inergen® gas fire suppression in line with local regulations and designed for maximum safety and minimum damage.



Sustainability

Zurich uses 100% renewable energy and is certified by myclimate® as the only carbon-neutral data centre in Switzerland. Our PUE measures are exceptional by any standards. We use free cooling and a custom cold-aisle containment solution to support higher power densities on low raised floors more efficiently, reducing the overall cooling overhead by as much as 30%.
